(3) As per intimation received by the Company under Regulation 30 (2) of SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 during May, 2020 and subsequent disclosures, the promoters have no control over Ruchi Soya Industries Limited (RSIL) now known as Patanjali Foods Limited by virtue of implementation of Resolution Plan in December, 2019. Such Resolution Plan was approved vide Orders passed by the National Company Law Tribunal, Mumbai Bench in the matter of RSIL in accordance with the provisions of Insolvency and Bankruptcy Code, 2016.

(4) During the quarter ended 31st March 2023, the Company made a preferential issue of 3,07,85,000 warrants each convertible (within the validity period of 18 months from the date of allotment) into one equity share of Re. 1/- at a price of Rs. 10.30 per warrant. Out of which 1,96,62,000 warrants were converted into equity shares before 31st March, 2024, in accordance with the terms of preferential issue and the remaining 1,11,23,000 warrants were converted on 5th August, 2024.

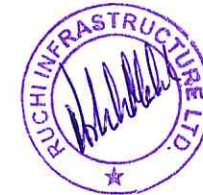
