- 1) The Board of Directors of the **M/s. Ruchi Infrastructure Limited** (CIN: L65990MH1984PLC033878) (hereinafter referred as the "Company") at its meeting held on 31st December, 2022 has appointed me as the Scrutinizer pursuant to Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Amendment Rules, 2014 including any statutory modification or re-enactment thereof for the time being in force and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for scrutinizing the Postal Ballot Forms / Remote e-voting in respect of Resolution as stated in the Postal Ballot Notice dated 31st December, 2022.
- 2) I submit my report as under:
 - (a) The Company had sent on 2nd January, 2023 the Notice of Postal Ballot electronically to all the members who have registered their e-mail addresses with the Company or with their Depositories/Depository Participant and whose names appear in the Register of Members/list of Beneficial Owners as on the Cut-off date i.e. 23rd December, 2022; in accordance with the guidelines prescribed by the Ministry of Corporate Affairs ("MCA") for holding general meetings/conducting postal ballot process through e-voting vide MCA Circulars.
 - (b) In compliance with MCA Circulars dated 8th April, 2020; 13th April, 2020, 31st December, 2020, 8th December, 2021 and 28th December, 2022 physical Postal Ballot Forms were not dispatched by the Company.
 - (c) The Remote e-voting period commenced on 3rd January, 2023 at 09.00 am IST and concluded on 1st February, 2023 at 5.00 p.m. IST, the e-voting services were provided by Central Depository Services (India) Limited ("CDSL").
 - (d) The votes were unblocked on 1st February, 2023 at around 05.17 p.m. IST in the presence of two witnesses CS Nikunj Kiri and CS Aashit Doshi who are not in the employment of the Company. The results of e-voting alongwith the List of members who voted "For" and "Against" the resolution were downloaded from the e-voting website of CDSL.
 - (e) Particulars of the votes cast by electronic mode have been entered in a register separately maintained electronically for the purpose.









